

MINUTES OF THE CSBF MEETIG HELD ON 11/12.12.2018

CSBF Committee meeting was held on 11/12.12.2018 and the following members were present:-

The following issues were discussed/decided:-

1. a) In 2018-19, 09 women camp have already been conducted.
b) Group 'D' camp of Thailand has been conducted successfully.
2. **CSBF committee member decided to conduct following camps :-**
 - a) Gr.'C' male camp at Darjiling & Gangtoke (2N Darjiling & 3N Gangtoke) will be conducted in the end of February of 2019. Notification should be issued within a week (by 19.12.2018.). Outside agency to be hired for organizing the camp.
 - b) Gr.'C' camp in Dubai:- it has been decided that one Group 'C' camp in Dubai will be conducted in the month of March 2019. For this camp 50% camp fee will be charged by the campers. So the expenditure ratio will be 50:50. Notification should be issued within a week (by 19.12.2018.)
 - c) Children camp in Singapore:- It has been decided that one Children camp will be conducted in Singapore in the month of May of 2019. For this camp 20% camp fee will be charged by the campers. Notification should be issued within a week (by 19.12.2018.)
- 3.) **SBF calendar** will be prepared before 31.12.2018. For this, Rs. 2 lakhs is sanctioned.
- 4.) **Book Bank:-** A Book Bank will be made functional in every Divisions and unit. In this regard Rs. 2 lakhs will be sanctioned for each Division & HQ and 1 l is sanctioned for each workshop.
- 5.) General reference will be sent to Railway Board to allow CSBF committee members to attend abroad camps as ON DUTY.

- 5) **Muskan scheme** will be reviewed since committee members have raise deficiencies in procedure. Till review, payment not to be done and scheme is kept in abeyance.
- 6) **Review of Relief and Distress Head** Amount against disease under Relief and Distress Head should be reviewed by CSBF committee members in next meeting. New rates will be applicable from 01.04.2019.
- 7) **Sardar Sarovar** (Kevadia) station, request to be sent to DRM-BRC & CAO(C), to include 6 Rooms for Holiday Homes adjoining to ORH.
